GCV USBC ASSOCIATION TOURNAMENT RULES

- 1 TEAM EVENT - Women & Open Divisions. \$20 per bowler. When a bowler is entered with two or more teams in the tournament their first score bowled shall count toward their all events score. Five person women's teams will be in the open division.
 - a. The same five open bowlers, or same four women can bowl & cash multiple times in the team event provided they bowl as a team in leagues.
 - b. Non-league roster teams will be allowed. No more than two (2) members may bowl together the second time and each time thereafter in the team event.TEAM WALK-IN: Multiple participation in team event for bowlers previously entered and paid in team event, if lanes are available. Rule 1.b applies
DOUBLES - Women & Open Division - \$20 per bowler/\$40 per doubles. Doubles will be bowled first. Must also bowl singles. May bowl doubles multiple times but with different partners. First doubles score shall count toward the all events score. Women must specify division or will be entered in the women's division.
DOUBLES WALK-IN: Multiple participation in doubles event for bowlers previously entered and paid in doubles, if lanes are available.
SINGLES - Women & Open Division - \$20 per bowler. Must also bowl doubles at least one time. May bowl singles only one time. Women must specify division or will be entered in the women's division.
- 2 PRIZES - AT LEAST ONE IN FOUR ENTRIES. Plaques for handicap & scratch team, doubles, singles champions.
- 3 OPTIONAL ALL EVENTS- Women & Open divisions - \$5 entry fee. TO ENTER OPTIONAL OPEN SCRATCH ALL EVENTS bowler must be entered in hdcp all event division. Women must enter at least one of the three women's events (T, D, S) to be entered in the women's all event division.
- 4 ALL EVENTS - AT LEAST ONE IN TEN ENTRIES. Plaques for women's, open and scratch champions.
A replacement may be made in the all events providing the replacement is made before the original entrant or replacement has bowled in the tournament.
- 5 HANDICAP - 90% of 1150 team average, doubles 90% of 460, singles and all events 90% of 230. A handicap series will be capped at 900.
- 6 AVERAGE USED - in the following order. Must be certified USBC Greater Cedar Valley league average.
 - a. Highest average as of December 23, minimum of 21 games.
 - b. Highest 12 game average in one league as of January 22.
 - c. If neither 6a or 6b average the bowler will use highest previous seasons book average.
 - d. A bowler must submit and use their adjusted Sport Bowling average if they do not have a standard league average (Rule 201c)
 - e. If bowler has none of the previous averages, they will be assigned an average of 230.
- 7 Full remittance must accompany entry blank unless other arrangements have been made with the tournament manager. Entries will be scheduled as completed forms and full payments are received. NO EXCEPTIONS. Personal checks will be accepted for the entry fee, but if the check comprising such entry is found non-negotiable the entry is canceled and will be subject to a \$25 service fee. Stop payment bank fees will be deducted from any reissued tournament prize checks.
- 8 Rule 319 d, e is waived; therefore rerating and tournament prize winnings need not be reported.
- 9 No tournament participant may practice on tournament lanes within one hour prior to squad times.
- 10 No line-up changes other than substitutions after entries close and no pacers will be allowed.
- 11 Reserved entry deadline is January 15. Late entries accepted at the tournament manager's discretion.
- 12 The GCV USBC Board of Directors shall decide any disputes not covered by the local association tournament rules, and their decision shall be final, unless their decision has been appealed to USBC. The decision of USBC is final and binding on all involved parties.
